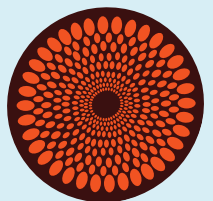
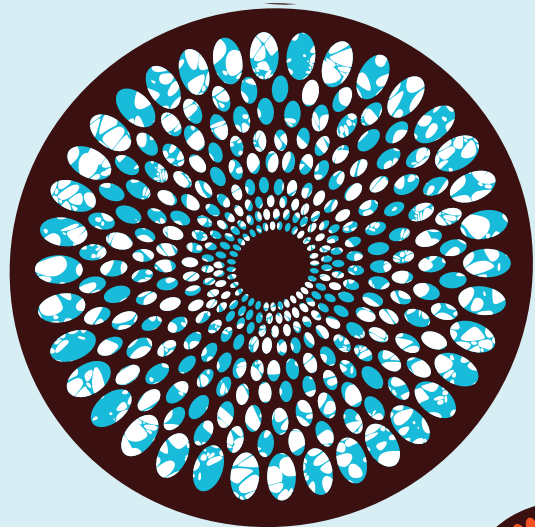


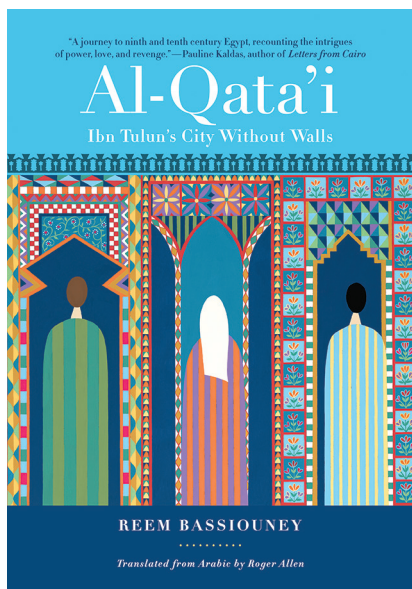
Dear Colleagues,

Brimming with intrigue, adventure, and romance, *Al-Qata'i: Ibn Tulun's City Without Walls* tells the epic story of visionary Egyptian leader Ahmad Ibn Tulun who built Al-Qata'i (now Cairo) into a thriving multicultural empire.

The novel begins with the rediscovery of the Ibn Tulun Mosque in 1918 and recounts Ibn Tulun's life and legacy in the ninth and tenth centuries. Bassiouney presents Ibn Tulun's benevolent vision to unify all Egyptians in a new city, Al-Qata'i. He becomes so focused on his vision, however, that he cannot see the impact it has on his family or the fate of Egypt. When a betrayal leads to his demise, the rival Abbasid caliph threatens to regain control of Al-Qata'i. In the aftermath of Ibn Tulun's death, his daughter Aisha emerges as a pivotal figure, bravely taking a stand against the Abbasids to preserve her life, the city, and the iconic mosque.

This contemporary Egyptian writer forces us to consider universal themes, such as diversity and equality, through both a historical and intercultural lens that enriches our understanding of these issues in our world today.

REEM BASSIOUNEY is an Egyptian author living in Cairo. She won the Naguib Mahfouz Award for best Egyptian novel for *Sons of the People: The Mamluk Trilogy*. She also won the 2009 Sawiris Foundation Literary Prize for Young Writers and the 2009 King Fahd Center for Middle East and Islamic Studies Translation of Arabic Literature Award.

ROGER ALLEN is an Arabic literature scholar and translator. He is credited with bringing Naguib Mahfouz to international recognition.

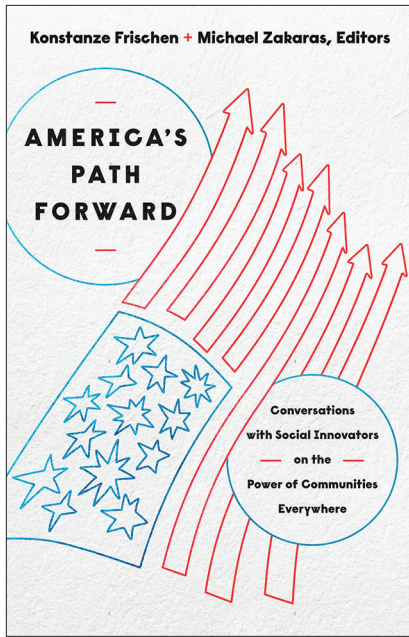

Cybersecurity vulnerabilities in the United States are extensive, affecting everything from national security and democratic elections to critical infrastructure and economy. In the past decade, the number of cyberattacks against American targets has increased exponentially, and their impact has been more costly than ever before. 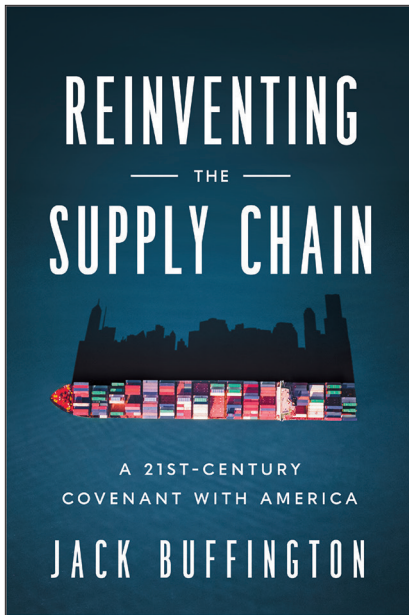

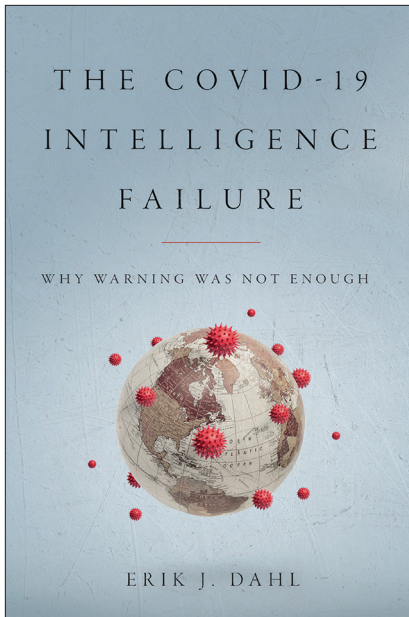

The COVID-19 Intelligence Failure

Why Warning Was Not Enough

ERIK J. DAHL

AN IN-DEPTH ANALYSIS OF WHY COVID-19 WARNINGS FAILED AND HOW TO AVERT THE NEXT DISASTER

Epidemiologists and national security agencies warned for years about the potential for a deadly pandemic, but in the end global surveillance and warning systems were not enough to avert the COVID-19 disaster. In *The COVID-19 Intelligence Failure*, Erik J. Dahl demonstrates that understanding how intelligence warnings work—and how they fail—shows why the years of predictions were not enough.

In the first in-depth analysis of the topic, Dahl examines the roles that both traditional intelligence services and medical intelligence and surveillance systems play in providing advance warning against public health threats—and how these systems must be improved for the future. For intelligence to effectively mitigate threats, specific, tactical-level warnings must be collected and shared in real time with receptive decision makers who will take appropriate action. Dahl shows how a combination of late and insufficient warnings about COVID-19, the Trump administration’s political aversion to scientific advice, and decentralized public health systems all exacerbated the pandemic in the United States. Dahl’s analysis draws parallels to other warning failures that preceded major catastrophes from Pearl Harbor to 9/11, placing current events in context.

The COVID-19 Intelligence Failure is a wake-up call for the United States and the international community to improve their national security, medical, and public health intelligence systems and capabilities.

ERIK J. DAHL is an associate professor in the National Security Affairs Department and a faculty member of the Center for Homeland Defense and Security at the US Naval Postgraduate School. He is the author of *Intelligence and Surprise Attack: Failure and Success from Pearl Harbor to 9/11 and Beyond* (Georgetown University Press, 2013).

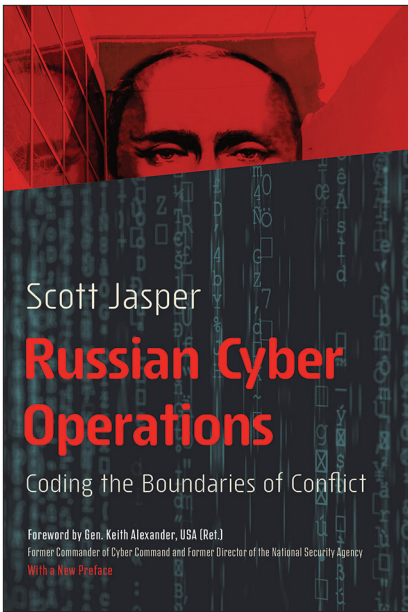

Russian Cyber Operations

Coding the Boundaries of Conflict

Russia has deployed cyber operations to interfere in foreign elections, launch disinformation campaigns, and cripple neighboring states—all while maintaining a thin veneer of deniability and avoiding strikes that cross the line into acts of war. How should a targeted nation respond? In *Russian Cyber Operations*, Scott Jasper dives into the legal and technical maneuvers of Russian cyber strategies, proposing that nations develop solutions for resilience to withstand future attacks.

Jasper examines the place of cyber operations within Russia’s asymmetric arsenal and its use of hybrid and information warfare, considering examples from French and US presidential elections and the 2017 NotPetya mock ransomware attack, among others. A new preface to the paperback edition puts events since 2020 into context. Jasper shows that the international effort to counter these operations through sanctions and indictments has done little to alter Moscow’s behavior. Jasper instead proposes that nations use data correlation technologies in an integrated security platform to establish a more resilient defense.

Russian Cyber Operations provides a critical framework for determining whether Russian cyber campaigns and incidents rise to the level of armed conflict or operate at a lower level as a component of competition. Jasper’s work offers the national security community a robust plan of action critical to effectively mounting a durable defense against Russian cyber campaigns.

CAPT. SCOTT JASPER, US Navy (Ret.), is a senior lecturer in the National Security Affairs Department at the US Naval Postgraduate School. He is the author of *Strategic Cyber Deterrence: The Active Cyber Defense Option* and the editor of *Conflict and Cooperation in the Global Commons* (Georgetown University Press, 2012), *Securing Freedom in the Global Commons*, and *Transforming Defense Capabilities: New Approaches for International Security*. He earned his PhD from the University of Reading, UK.

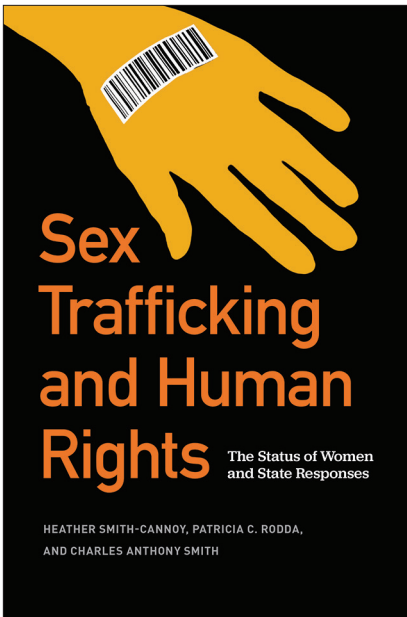

CASE STUDIES EXPLORE HOW WOMEN'S RIGHTS SHAPE STATE RESPONSES TO SEX TRAFFICKING AND SHOW HOW POLITICALLY EMPOWERING WOMEN CAN HELP PREVENT AND COMBAT HUMAN TRAFFICKING

Human trafficking for the sex trade is a form of modern-day slavery that ensnares thousands of victims each year, disproportionately affecting women and girls. While the international community has developed an impressive edifice of human rights law, these laws are not equally recognized or enforced by all countries. *Sex Trafficking and Human Rights* demonstrates that state responsiveness to human trafficking is shaped by the political, social, cultural, and economic rights afforded to women in that state.

While combatting human trafficking is a multi-scalar problem with a host of conflating variables, this book shows that a common theme in the effectiveness of state response is the degree to which women and girls are perceived as, and actually are, full citizens. By analyzing human trafficking cases in India, Thailand, Russia, Nigeria, and Brazil, they shed light on the factors that make some women and girls more susceptible to traffickers than others.

This important book is both a call to understanding and a call to action: if the international community and state governments are to responsibly and effectively combat human trafficking, they must center the equality of women in national policy.

HEATHER SMITH-CANNOY is an associate professor of political science at Arizona State University. She directs the Global Human Rights Hub and the Social Justice and Human Rights program. She is the author of *Insincere Commitments: Human Rights Treaties, Abusive States and Citizen Activism* (Georgetown University Press, 2012).

PATRICIA C. RODDA is an assistant professor of international relations at Carroll University.

CHARLES ANTHONY SMITH is a professor in political science and law at the University of California, Irvine. Beginning in July 2022, he will be the editor in chief for *Political Research Quarterly*.

Mao's Army Goes to Sea

The Island Campaigns and the Founding of China's Navy

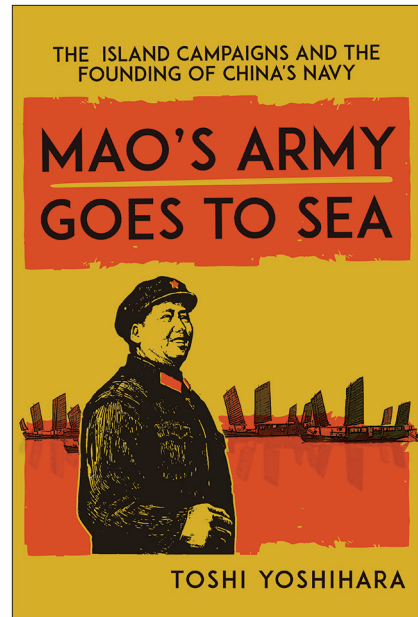

From 1949 to 1950, the People's Liberation Army (PLA) made crucial decisions to establish a navy and secure China's periphery. The civil war had been fought with a peasant army, yet in order to capture key offshore islands from the Nationalist rival, Mao Zedong needed to develop maritime capabilities. *Mao's Army Goes to Sea* is a groundbreaking history of the founding of the Chinese navy and Communist China's earliest island-seizing campaigns.

In this definitive account of a little-known yet critical moment in China's naval history, Toshi Yoshihara shows that Chinese leaders refashioned the stratagems and tactics honed over decades of revolutionary struggle on land for nautical purposes. Despite significant challenges, the PLA ultimately scored important victories over its Nationalist foes as it captured offshore islands to secure its position.

Drawing extensively from newly available Chinese-language sources, this book reveals how the navy-building process, sea battles, and contested offshore landings had a lasting influence on the PLA. Even today, the institution's identity, strategy, doctrine, and structure are conditioned by these early experiences and myths. *Mao's Army Goes to Sea* will help US policymakers and scholars place China's recent maritime achievements in proper historical context—and provide insight into how its navy may act in the future.

TOSHI YOSHIHARA is a senior fellow at the Center for Strategic and Budgetary Assessments and an adjunct professor in the Security Studies Program at Georgetown University. He was previously the John A. van Beuren Chair of Asia-Pacific Studies at the US Naval War College and coauthored *Red Star over the Pacific: China's Rise and the Challenge to US Maritime Strategy*.

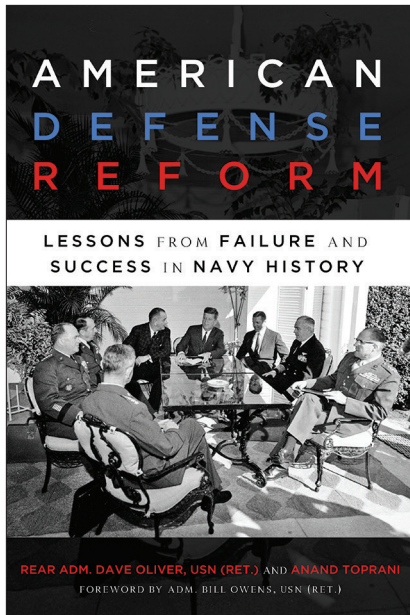

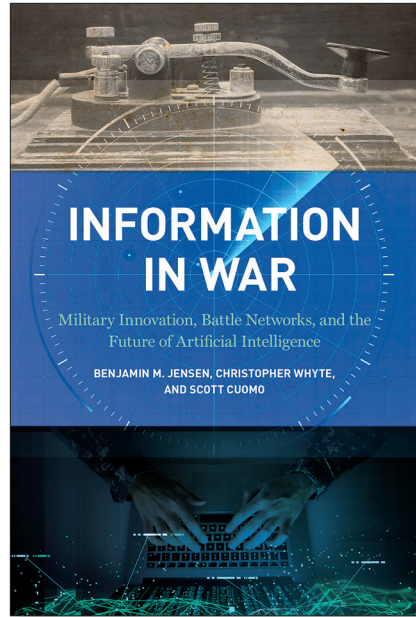

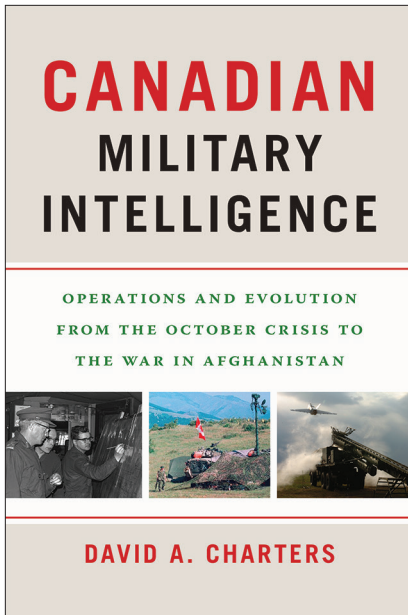

One of the most important developments in today's changing international system is the emergence of India as a rising power. However, Rajesh Basrur finds that India is held back by serious domestic constraints. *Subcontinental Drift* explains why India's foreign policy is often characterized by multiple hesitations, delays, and diversions that may ultimately hamper its rise.

Basrur analyzes the concept of policy drift through the lens of neoclassical realist theory to reveal why this drift occurs so regularly in Indian foreign policy and how it affects India's quest for major power status. Using four cases—the India-US strategic partnership, India-Sri Lanka relations, India's nuclear strategy, and crossborder terrorism—Basrur identifies two basic explanations for India's indecision on critical issues. The first, involuntary drift, is related to the distribution of domestic material power, while the second, voluntary drift, is produced by a responsibility deficit.

Basrur develops a fresh theoretical basis for understanding the relationship between India's foreign and domestic policies and introduces a series of theoretical refinements to neoclassical realism. *Subcontinental Drift* also provides advice on how policy makers might lower the costs of policy drift. This innovative analysis is essential to understanding the constraints around India's foreign and domestic security decisions and how they will affect its rise.

RAJESH BASRUR is a senior fellow in the South Asia Program at the S. Rajaratnam School of International Studies in the Nanyang Technological University in Singapore. Concurrently, he is a research associate with the Contemporary South Asian Studies Program at the Oxford School of Global and Area Studies in the University of Oxford. Previously, he was a professor of international relations at the Rajaratnam School; he taught at the University of Mumbai; and he held numerous visiting positions, including at the University of Oxford, Stanford University, and the Brookings Institution. He is the author (with Kate Sullivan de Estrada) of *Rising India: Status and Power, South Asia's Cold War*, and *Minimum Deterrence and India's Nuclear Security*.

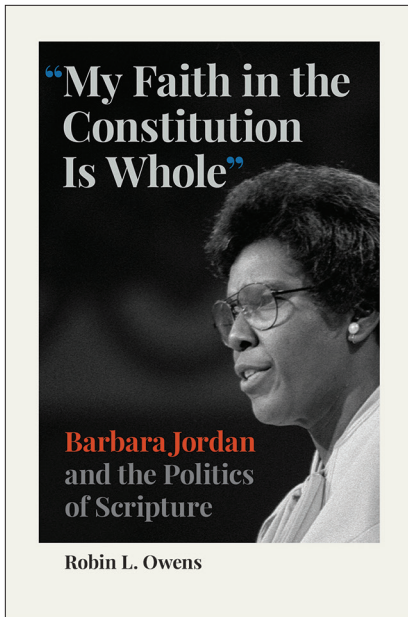

“My Faith in the Constitution Is Whole”

Barbara Jordan and the Politics of Scripture

ROBIN L. OWENS

HOW BARBARA JORDAN USED SACRED AND SECULAR SCRIPTURES IN HER SOCIAL ACTIVISM

US Congresswoman Barbara Jordan is well-known as an interpreter and defender of the Constitution, particularly through her landmark speech during Richard Nixon’s 1974 impeachment hearings. However, before she developed faith in the Constitution, Jordan had faith in Christianity. In *“My Faith in the Constitution is Whole”: Barbara Jordan and the Politics of Scripture*, Robin L. Owens shows how Jordan turned her religious faith and her faith in the Constitution into a powerful civil religious expression of her social activism.

Owens begins by examining the lives and work of the nineteenth-century Black female orator-activists Maria W. Stewart and Anna Julia Cooper. Stewart and Cooper fought for emancipation and women’s rights by “scripturalizing,” or using religious scriptures to engage in political debate. Owens then demonstrates how Jordan built upon this tradition by treating the Constitution as an American “scripture” to advocate for racial justice and gender equality. Case studies of key speeches throughout Jordan’s career show how she quoted the Constitution and other founding documents as sacred texts, used them as sociolinguistic resources, and employed a discursive rhetorical strategy of indirection known as “signifying on scriptures.”

Jordan’s particular use of the Constitution—deeply connected with her background and religious, racial, and gender identity—represents the agency and power reflected in her speeches. Jordan’s strategies also illustrate a broader phenomenon of scripturalization outside of institutional religion and its rhetorical and interpretive possibilities.

ROBIN L. OWENS is an associate professor of religious studies at Mount Saint Mary’s University in Los Angeles. Her research interests focus on intersections between religion and culture, specifically the role and function of religion in identity formation and power negotiation.

Tragic Dilemmas in Christian Ethics

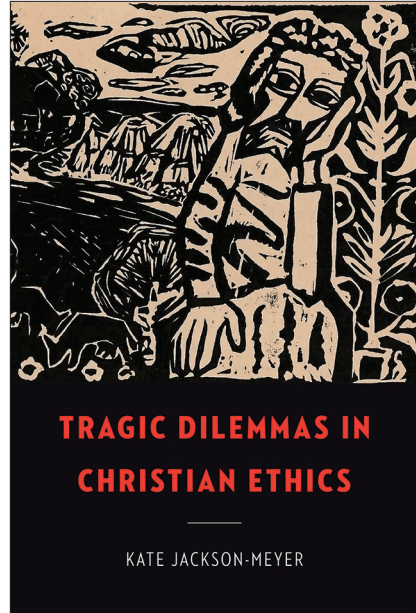
THE FIRST BOOK TO ARGUE FOR THE CONCEPT OF TRAGIC DILEMMAS IN CHRISTIAN ETHICS

Moral dilemmas arise when individuals are unable to fulfill all of their ethical obligations. Tragic dilemmas are moral dilemmas that involve great tragedy. The existence of moral and tragic dilemmas is debated in philosophy and often dismissed in theology based on the notion that there are effective strategies that completely solve hard ethical situations. Yet cases from real-life events in war and bioethics offer compelling evidence for the existence of tragic dilemmas.

In *Tragic Dilemmas in Christian Ethics*, Jackson-Meyer expertly explores the thought of Augustine and Aquinas to show the limits of their treatment of hard cases, as well as where their thought can be built on and expanded in relation to tragic dilemmas. She recognizes and develops a new theological understanding of tragic dilemmas rooted in moral philosophy, contemporary case studies, and psychological literature on moral injury. Jackson-Meyer argues that in tragic dilemmas moral agents choose between conflicting nonnegotiable moral obligations rooted in Christian commitments to protect human life and the vulnerable. Personal culpability is mitigated due to constrained situations and society is also culpable when tragic dilemmas are a result of structural sin. In response, Jackson-Meyer implores Christian communities to offer individual and communal healing after tragic dilemmas and to acknowledge their own participation in injustice.

Tragic Dilemmas in Christian Ethics offers practical strategies that Christian communities can use to provide healing to those who have acted in tragic dilemmas and to transform the unjust structures that often cause these tragedies.

KATE JACKSON-MEYER is a member of the faculty in the Theology Department at Boston College. Her scholarship and teaching are focused on theological ethics, bioethics, and the ethics of war and peacemaking.

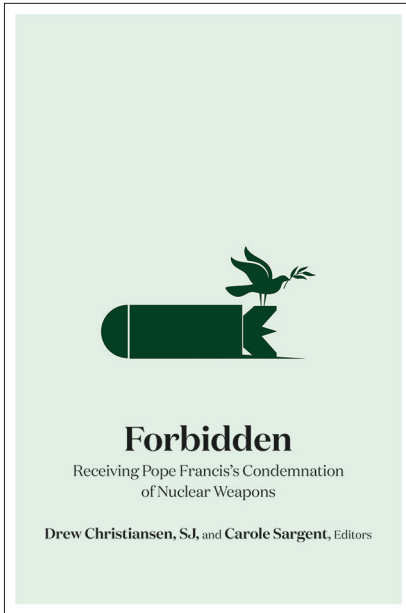

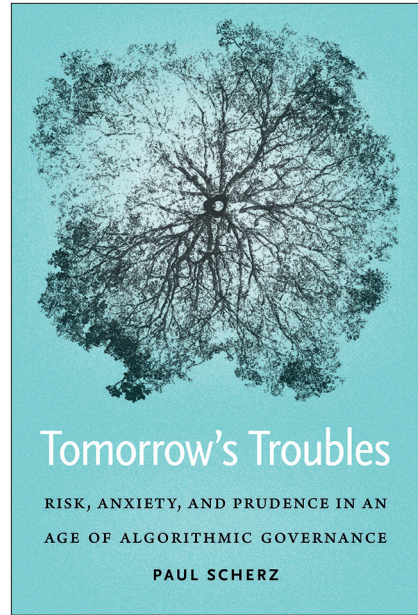

Probabilistic predictions of future risk govern much of society. In business and politics alike, institutional structures manage risk by controlling the behavior of consumers and citizens. New technologies comb through past data to predict and shape future action. Choosing between possible future paths can cause anxiety as every decision becomes a calculation to achieve the most optimal outcome.

Tomorrow's Troubles is the first book to use virtue ethics to analyze these pressing issues. Paul Scherz uses a theological analysis of risk and practical reason to show how risk-based decision theory reorients our relationships to the future through knowledge of possible dangers and foregone opportunities—and fosters a deceptive hope for total security. Scherz presents this view of temporality as problematic because it encourages a desire for stability through one's own efforts instead of reliance on God. He also argues that the largest problem with predictive models is that they do not address individual reason and free will. Instead of dwelling on a future we cannot control, we can use our past experiences and the Christian tradition to focus on discerning God's will in the present.

Tomorrow's Troubles offers a thoughtful new framework that will help Christians benefit from the positive aspects of predictive technologies while recognizing God's role in our lives and our futures.

PAUL SCHERZ is an associate professor of moral theology and ethics in the School of Theology and Religious Studies at the Catholic University of America. He is the author of *Science and Christian Ethics*. He has a PhD in theology from the University of Notre Dame and a PhD in genetics from Harvard University.

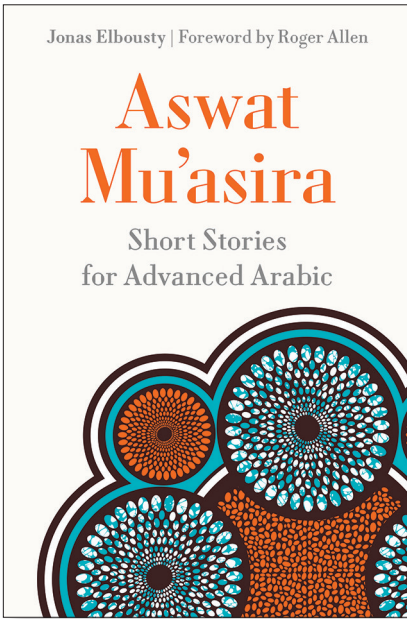

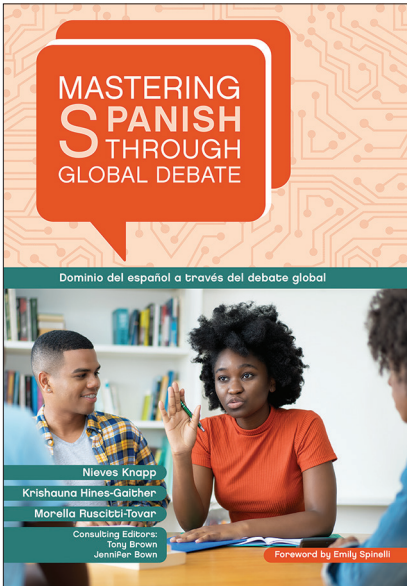
